

2025 PRESIDENTIAL ELECTION: GECAM CALLS FOR AN ECONOMIC BOOST

As ideas and public policies are refined and finalized for presentation to voters as programs for the October 12, 2025 presidential election, it is crucial that the priorities of businesses of all sizes and sectors, the driving force behind growth, employment, and structural transformation, are addressed concretely and ambitiously by candidates for the Supreme office.

To the presidential candidates, GECAM expresses the hope that the upcoming election campaign will be an opportunity for a genuine debate of ideas, based on clear, credible, costed programs and projects whose potential and real impact will be measurable.

For several years, the private sector has played its role as a source of ideas, through numerous proposals; it has helped identify concrete levers to improve the state of infrastructure, promote industrialization, support formal entrepreneurship, strengthen our economy's competitiveness, and improve economic governance.

Unfortunately, many of these proposals have not been acted upon, or have only been partially or belatedly implemented.

That is why we will be paying close attention to the candidates' programmes, particularly the measures they propose to:

- Reform our tax system;
- Accelerate infrastructure development:
- Put an end to power cuts;
- Effectively digitise public services:
- Guarantee greater legal and judicial security:
- Ensure the stability and clarity of investment incentives;
- Adapt training to the real needs of the economy;
- Actively support industrialisation and productive sovereignty.

The presidential election on October 12, 2025 cannot be just another routine political event. Regardless of the outcome, this election must mark a break from an outdated model.

The upcoming election therefore represents a historic opportunity to rebuild our Republic around a State that serves its citizens and guarantees freedoms, economic justice and shared progress.

In the new era that Cameroon is aspiring to, business cannot be ignored. All players in the national political market recognise it as the essential foundation for development, as well as a creator of solutions, jobs, cohesion and sovereignty.
